

## Working procedure: Instructions for slot requests for Commercial and General Aviation

Working procedure slot requests for commercial and general aviation at Amsterdam Airport Schiphol.

#### 1. References

- 1.1. The Council Regulation (EC) No 95/93, as amended, and the IATA Worldwide Slot Guidelines (WSG), latest and current edition, are the basis for slot allocation within the limits of the capacity declaration Amsterdam Airport Schiphol (applicable season as published on <a href="https://www.slotcoordination.nl">www.slotcoordination.nl</a>).
- 1.2. The planning limit as defined in the capacity declaration is applicable for commercial aviation only. Nominal operational runway capacity is applicable for both commercial and general aviation.
- 1.3. The Local Rule Schedule Coordination for General Aviation (GA) at Amsterdam Airport Schiphol, latest and current edition as published on <a href="https://www.slotcoordination.nl">www.slotcoordination.nl</a>, is applicable for requesting and allocating slots. The following definitions are important:
  - Commercial aviation: flights performed by an air carrier, providing scheduled flights, programmed charters or ad hoc flights which are open for individual bookings for passengers and/or freight and/or mail, including positioning flights which are directly linked to the operation of these flights;
  - General Aviation: all aviation except commercial aviation. Including but not limited to business aviation, air taxi operations and technical flights.

For both types of aviation it is necessary to have been allocated a slot by ACNL, with the exception of State flights, emergency landings and humanitarian flights.

1.4. Slots are requested in SCR or GCR in conformity with the IATA Standard Schedules Information Manual (SSIM), latest and current edition, or – if available for coordination – through <a href="www.e-airportslots.aero">www.e-airportslots.aero</a>. This working procedure describes which type of traffic shall be requested in SCR or GCR format. A courtesy instruction for creating SCRs and GCRs can be found on <a href="www.slotcoordination.nl">www.slotcoordination.nl</a>. General aviation operators are advised to requests slots through their respective handling agent.



# 2. Instructions for requesting slots

- 2.1. Table 1 defines per type of aviation, traffic type and IATA SSIM Service Type Code (STC) the message format for requesting slots (SCR or GCR).
- 2.2. When applying for slots, airlines act in conformity with Table 1.
- 2.3. It is at the discretion of ACNL to deny the request when it is suspected that the format in which slots are requested or the STC with which slots are requested, deviate from the intended type of operation.
- 2.4. In accordance with Council Regulation (EC) No 95/93, as amended, Article 14, paragraph 4, and the Local Rule Schedule Coordination for General Aviation (GA) at Amsterdam Airport Schiphol, ACNL will monitor the use of slots.
